### 2. General Provisions

2.1. Matters not regulated in these terms, as well as the interpretation of these terms, are governed by Hungarian law, with particular reference to Act V of 2013 on the Civil Code ("Ptk.") and Act CVIII of 2001 on Electronic Commerce Services and Certain Aspects of Information Society Services ("Elker. tv."). The mandatory provisions of the applicable legislation apply to the parties without any specific stipulation.

2.2. These Terms & Conditions have been in effect since July 7, 2023, and remain in force until revoked. The Company reserves the right to unilaterally modify these visitor regulations. Any modifications will be published on the website at least seven (7) days before their effective date. Customers accept that all regulations related to the use of the website automatically apply to them by using the website.



2.3. The Service Provider reserves all rights related to the website, its content, and its distribution. Downloading, electronically storing, processing, or selling any content appearing on the website is prohibited. Cinema Mystica's general opening hours: 10:00 - 22:00 (Ticket office closes at 21:00).

Opening hours may vary during peak periods.

Online tickets grant fast-track entry within a 1-hour time slot. Outside this time slot, standard entry applies.

For on-site ticket purchases, it is advisable to arrive 10-15 minutes early.

In case of a full house, we may temporarily restrict ticket sales on site.

### **5. Mobile Phone Use**

Please mute or turn off your mobile phone, except when using it for photography.

### **6. Photography**

Photography for professional or commercial purposes requires prior written permission from the Service Provider.

Failure to comply with these rules may result in the organizers requesting cessation of photography or expulsion from the premises.

### **7. Conduct Rules**

Loud talking and any behavior inconsistent with museum norms is not permitted.

Visitors who violate the rules will receive a warning, and if necessary, will be asked to leave the venue.

### **8. Protection of Exhibition Items**

Please respect the exhibits and maintain the required distance. Do not litter, do not use open flames, and do not cause any damage.

Parents or guardians must supervise their children, as they are financially responsible for any damages caused by them.

Causing damage may result in legal consequences.

### **9. Food and Drink Consumption**

Consumption of food and alcoholic beverages is not allowed within the exhibition area. Drinks may only be brought into the exhibition area in a resealable bottle.





## **10. Smoking**

Smoking and the use of e-cigarettes are strictly prohibited throughout the building.

## **11. Animals**

Unfortunately, pets are not allowed.

## **12. Take Care of Your Belongings!**

For your convenience, please use the on-site cloakroom.

We do not take responsibility for any items left in the exhibition area.

## **13. Cloakroom**

The organizers are not responsible for valuables and for the integrity of fragile items left in the cloakroom.

The maximum bag size allowed in the cloakroom is 30x40 cm, suitcases cannot be stored throughout the museum.

## **14. Age Restrictions**

The exhibition is not recommended for children under 6 years old, as the light and sound effects may be overwhelming.

If you choose to bring a young child, the responsibility lies entirely with the parent or guardian.

Visitors under 14 years old must be accompanied by an adult.

## **15. Prohibited Items**

It is prohibited to bring the following items into the exhibition area: weapons or objects resembling weapons, items or substances that pose a danger to life, physical safety, or public security, bicycles, scooters, roller skates, skateboards, bags larger than 20x30 cm, umbrellas, or any other sports equipment.

## **16. Entry Conditions**

A person will not be permitted entry to the exhibition area if they are under the influence of alcohol or any other substance or if they are dressed in an inappropriate manner. The organizers reserve the right to immediately expel any visitor who violates these Terms & Conditions, behaves in a manner inconsistent with social norms, or causes public offense. In such cases, the visitor is not entitled to a refund of the admission fee.

## **17. Miscellaneous Provisions**

Any matters not addressed in these regulations are governed by the Hungarian Civil Code (Act V of 2013) and Government Decree 45/2014 (II. 26.) on contracts concluded with consumers at a distance.

**Children's ticket:** available for children under 12, free for visitors under 3.

**Group discount:** for groups of 10 or more, we can offer a group discount, with the price paid in one amount.
